### 2. PERSONAL DATA SUBJECT TO PROCESSING

## a) Browsing data

The legal basis of the processing is art. 6 par. 1 letter b): execution of pre-contractual measures, also adopted at the request of the data subject.

Data retention period: 1 year for contacts

**Newsletter subscription:** request for subscription to newsletters, information and/or commercial communications, in relation to **CIPRIANI PHE SRL** products or services

The legal basis of the processing is art. 6 par. 1 letter a): consent

Data retention period: Duration of service | opt out included in all communications

Besides what is specified for browsing data, the user is free to provide the personal data. The provision of data is optional, however failure to provide the data marked with the symbol\* or wording (requested), will make it impossible to obtain the information requested through the form and, therefore, receive communication via the mailing list service.

# 4. PROCESSING METHOD

Data processing will be executed automatically or manually, using methods strictly related to the purposes indicated and, in any case, to guarantee security and confidentiality of the data, by persons authorised to do so. This data will be stored, as specified above, for the time strictly necessary to provide you with the requested services and will, in any case, be eliminated following your request, without prejudice to further conservation obligations required by law.

# 5. POSSIBLE RECIPIENTS AND CATEGORIES OF RECIPIENTS OF PERSONAL DATA

Without prejudice to any other administrator or jurisdictional appeal, the data subject who considers that the processing in question violates the GDPR, has the right to complain to the Guarantor of personal data protection in the manner described on the site www.garanteprivacy.it (art. 77 of the above regulation).
